1. OBJECTIVES OF THE MOU

Either party shall have the right to unilaterally terminate this MoU upon 60 days' prior written notice to the other party.

Nothing in this MoU shall be construed to make either party, a partner, an agent or legal representative of the other for any purpose.

It is understood by the Parties herein this MoU is based on the professional competence and expertise of each party and hence neither Party shall transfer or assign this Agreement, or rights or obligations arising hereunder, either wholly or in part, to any third party.

7. SIGNED IN DUPLICATE


