RESTORATION ORDER

WHEREAS, recognition was granted to the institution namely MANDSAUR INSTITUTE OF PHYSICAL EDUCATION RUN BY B.R. NAHATA SMRITI SANSTHAN, REWA-DEWDA ROAD, MANDSAUR, MADHYA PRADESH, PIN CODE-458002 under section 14 (3)A of NCTE Act, 1993 for conducting B.P.Ed (CO-ED) course, with an annual intake of 50 students vide order no. WRC/5-6/104th/2008/37873-37878 dated 29.07.2008.

- 2. **AND WHEREAS**, the Revised Recognition order was issued to MANDSAUR INSTITUTE OF PHYSICAL EDUCATION RUN BY B.R. NAHATA SMRITI SANSTHAN, REWA-DEWDA ROAD, MANDSAUR, MADHYA PRADESH, PIN CODE-458002 vide order no. F.No.NCTE/WRC/APW05907/224153/REVISED ORDER{M.P}/2015/136055-136062 dated. 20.05.2015 for B.P.Ed. Course of Two Years Duration with an annual intake of 100 students (One Basic unit with two sections of 50 each) from the academic session 2015-2016.
- 3. **AND WHEREAS,** the matter was placed in 255th Meeting of WRC held on 22ND TO 24TH, June, 2016 and the Committee decided to issue Show Cause Notice to the institution, Accordingly, Show Cause Notice issued to the institution on 01.02.2017 and institution has not submitted reply.
- 4. **AND WHEREAS,** matter was placed in 301st Meeting of WRC held on 17th-18th, January, 2019 and Committee decided that for non-submission of reply from the institution in response to show cause notice dated 01.02.2017, recognition is withdrawn from the academic session 2019-2020. FDRs, if any, be returned. Accordingly, withdrawal Order was issued to the institution vide no. WRC / APW05907 / 224153 /B.P.Ed / 301st / {M.P} /2019/201137 to 201145 dated. 23.01.2019.
- AND WHEREAS, being aggrieved the institution filed an appeal and NCTE Appellate Authority remanded back the case vide order dated 03.06.2019.
- 6. **AND WHEREAS,** matter was placed in 309th meeting of WRC held on 23rd to 26th, July, 2019 and Committee decided to issue Show Cause Notice to the institution, Accordingly, Show Cause Notice u/s 17 was issued to the institution on 08.08.2019 and institution has not submitted reply.
- 7. **AND WHEREAS,** the institution has filed W.P. (C) No. 9012/2019 in the Hon'ble High Court of Delhi at New Delhi and the Hon'ble Court passed an order dated 20.08.2019 which is as follows:
 - "... The Western Regional Committee is thus, directed to reconsider the matter in terms of the order dated 03.06.2019 of the Appellate Authority i.e. the NCTE. Till the disposal of such proceedings, the order of withdrawal of recognition of the petitioner's institute vide the order dated 23.01.2019 of the Western Regional Committee having been set aside, the petitioner is allowed to participate in the ongoing counselling process for the academic year 2019-20.

The petition is disposed of accordingly."

- 8. **AND WHEREAS,** matter was placed in 314th meeting of WRC held on 13th to 15th and 22nd July, 2020 and committee decided that last opportunity be given to the institution to reply within 30 days u/s 17 of the NCTE Act. Accordingly, Final Show Cause Notice was issued to the institution on 05.08.2020 and institution has submitted Show Cause Notice reply on 31.08.2020
- 9. **AND WHEREAS,** the institution has filed W.P. (C) No. 12716/2022 in the Hon; ble High Court of Delhi at New Delhi and the Hon'ble Court passed an order dated 02.09.2022, which is as follows:
- "... Respondents are directed to issue a restoration order in terms of the directions of the Appellate Authority within a period of two weeks from today. Respondents are also directed to display the name of Petitioner-college in the list/category of recognised institutions for conducting B.Ed. course on their website. The same shall also be communicated to the affiliating university as well as the Department of Higher Education, Government of Madhya Pradesh to enable the petitioner-college to participate in counselling and admission process for academic year 2022-23 and for subsequent years, unless a withdrawal order is passed."

 AND WHEREAS, matter was placed in 373rd meeting of WRC held on 08th October, 2022 and Committee decided as under:

"The original file of the Institution along-with other related documents, Order dated 02.09.2022 in W.P.(C) 12716/2022 passed by Hon'ble High Court of Delhi, representation dated 24.08.2020 in response to final Show Cause Notice dated 05.08.2020 were carefully examined in the light of NCTE Act, 1993, Regulations and Guidelines issued by NCTE from time to time and the Committee decided that in compliance of direction of Hon'ble Court, recognition to B.P.Ed. Course be restored till a fresh withdrawal order is issued by WRC. The institution is permitted to participate in the counselling being conducted for admission to B.P.Ed. course by the affiliating body/ concerned State Govt. for the academic session 2022-23 and for subsequent years till a fresh withdrawal order is issued by WRC. The concerned State authorities be intimated accordingly. A copy of restoration order be also uploaded on the WRC web portal on NCTE website."

- 11. **NOW THEREFORE**, the recognition of the institution viz MANDSAUR INSTITUTE OF PHYSICAL EDUCATION RUN BY B.R. NAHATA SMRITI SANSTHAN, REWA-DEWDA ROAD, MANDSAUR, MADHYA PRADESH, PIN CODE-458002 for conducting the B.P.Ed. programme of two years duration with an annual intake of 100 students (One Basic unit with two sections of 50 each is hereby restored till a fresh withdrawal order is issued by WRC and the institution is permitted to participate in the counselling being conducted for admission to B.P.Ed. course by the affiliating body/concerned State Govt. for the academic session 2022-23 and for subsequent years till a fresh withdrawal order is issued by WRC.
- 12. The terms and conditions shall remain same mentioned in the revised recognition order issued vide order no. 136055-136062 date. 20.05.2015.
